**FROM:** New Jersey Division of Pensions & Benefits (NJDPB)  
**SUBJECT:** **Reimbursement of 2020 Medicare Part B and Part D Premiums for Retirees Who Were Subject to Additional Income-Related Premiums in 2020**

This notice is for eligible retirees who qualify for reimbursement of the full cost of Medicare Part B and Part D Coverage from the State of New Jersey and paid more than the standard monthly premium during 2020.

**If you paid only \$144.60 per month for Medicare Part B premiums in 2020, you are not owed any additional reimbursement and should disregard this letter.**

If you or your eligible spouse/partner paid more than \$144.60 per month for Medicare Part D coverage, please forward:

1. A copy of the Cost-of-Living Adjustment letter(s) you received from Social Security in November of 2019 notifying you of your 2020 Medicare Part B and Part D premium increases and the income-related premiums. If you need a copy of this letter, contact your local Social Security Office. If you are unable to locate the Cost-of-Living Adjustment letter, please forward a copy of the first two pages of your 2018 federal tax return; **and**
2. A copy of your 2020 Social Security Form SSA-1099 (or Form RRB-1099 if in the Railroad Retirement System). If you do not receive a Form SSA-1099, you must submit other proof of Medicare Part D premium payments for 2020. Proof of payment may be shown by forwarding copies of monthly billing statements or canceled checks. **Please do not staple.**

**Electronic documents can now be submitted through Online Document Submission in your Member Benefits Online System (MBOS) account. Once the documents are reviewed, an update will show if the documents are accepted or rejected. Please ensure your correct email address is listed in MBOS so we can notify you in case a document is rejected.**

Online document submission is the quickest and easiest way to ensure your documents are received in a timely fashion by the NJDPB. If using this method, documents must be received no later than April 1, 2021.

If you are eligible for reimbursement of Medicare Part D premiums, you will receive checks representing the unreimbursed balance you paid in 2020. Reimbursement checks will be issued beginning April 30, 2021.

You must forward the requested information by April 1, 2021, in order to receive a reimbursement check. No 2020 reimbursements will be issued if requested after the April 1, 2021 filing deadline.

If you or your eligible spouse/partner did not pay an additional premium for Part B or Part D coverage, you are **not** eligible for any additional reimbursements. In addition, if you pay a higher Medicare Part B or Part D premium due to a late enrollment penalty, you will not be reimbursed for the penalty.

Due to high mail volume, please allow a minimum of four months to process your reimbursement from the time received in to our office.
