Protest of Notice of Intent to Award

Dear Mr. Haines:

This letter is in response to your correspondence of August 22, 2019, on behalf of Haines Towing, Inc. (Haines) to the Division of Purchase and Property's (Division) Hearing Unit requesting that the State re-bid the unfulfilled price lines or cancel Bid Solicitation #19DPP00334 T2171 – Vehicle Towing and Roadside Services (Bid Solicitation). In support of the request, Haines states in part that there was systemic problem with the State's certification process of Small Business Enterprises. The record of this procurement reveals that the Division's Procurement Bureau (Bureau) deemed Haines' Quote non-responsive to the requirements of the Bid Solicitation because it was not certified as a Small Business Enterprise as of the Quote opening date.

By way of background, on January 18, 2019, the Bureau issued the Bid Solicitation on behalf of the Bureau of Transportation Services, Division of Administration, Department of the Treasury (Transportation), to solicit Quotes from qualified Vendors {Bidders} to provide vehicle towing and roadside repair services. Bid Solicitation § 1.1 Purpose and Intent. It is the State's intent to award up to five Blanket P.O.s in each county to those responsible Vendors {Bidders} whose Quotes, conforming to this Bid Solicitation is most advantageous to the State, price and other factors considered. Ibid. On February 28, 2019, the Bureau issued Bid Amendment #1 extending the Quote submission deadline to April 3, 2019. On March 25, 2019, the Bureau issued Bid Amendment #2 responding to the questions received from potential Vendors {Bidders} and extending the Quote submission deadline to April 11, 2019.

On April 11, 2019, the Division's Proposal Review Unit opened 34 Quotes received by the submission deadline of 2:00 pm eastern time. On July 30, 2019, after completing its review and evaluation of the Quotes received, the Bureau completed a recommendation report which recommended Blanket P.O. awards be made to sixteen Vendors {Bidders} whose submitted Quotes were most advantageous to the State, price and other factors considered. On August 9, 2019, the Bureau issued a Notice of Intent to Award Letter (NOI) advising all Vendors {Bidders} that it was the State's intent to award Blanket P.O.s to the following Vendors {Bidders}:

On August 22, 2019, Haines submitted a protest to the Division's Hearing Unit. In support of its protest and its request that the Division cancel and re-bid this Bid Solicitation, Haines states the following: (1) that it did not receive notice of the requirement that it submit its annual verification; (2) that it was unable to complete the process on-line in August and was told to submit a paper application; and, (3) that there must have been a systemic problem with the certification system as "nearly half of the 34 applicants" were disqualified. See, Haines' protest letter p. 2.

In consideration of Haines' protest, I have reviewed the record of this procurement, including the Bid Solicitation, the Quotes received, the protest, the relevant statutes, regulations, and case law. This review has provided me with the information necessary to determine the facts of this matter and to render an informed final agency decision on the merits of the protest submitted by Haines. I set forth herein my final agency decision.

In 1983 the New Jersey Legislature enacted the "Set-Aside Act for Small-Businesses, Female Businesses and Minority Businesses." See, N.J.S.A. 52:32-17 et seq. The law required that the Division, when setting contracts aside for award to Small Business Enterprises advise the bidding community of the same and reject all Quotes from those businesses that are not certified as of the Quote opening date. See, N.J.S.A. 52:32-25. The regulations promulgated by the Department of the Treasury regarding Small Business Set-Asides similarly states "[i]f a business is to be eligible to bid on a specific set-aside contract or participate in the subcontracting target programs for purposes of this chapter, it must be registered as a small or veteran-owned business by [Division of Revenue and Enterprise Services (DORES)] on or before the date the bid or proposal is due at the State contracting agency." See, N.J.A.C. 17:13-3.2. A review of the subject Bid Solicitation reveals that all Vendors {Bidders} were put on notice that awards would be confined to those businesses certified as Small Business Enterprise as of the Quote opening date. Specifically, the Bid Solicitation stated that:

Pursuant to the provisions of N.J.S.A. 52:32-17 and N.J.A.C. 17:13 this is a full Set-Aside Blanket P.O. for Category I, II, & III for Small Businesses. The Vendor {Bidder} must¹ be registered as a qualifying small business with the Division of Revenue and Enterprise Services, Small Business Registration and M/WBE Certification Services Unit by the date the Quote is received and opened. Evidence that the Vendor {Bidder} has registered as a small business should be submitted with the Quote. Vendors {Bidders} should verify its Small, Minority, Veteran, and Women Owned Business Certification status on the "Maintain Terms and Categories" Tab within its profile in NJSTART. In the event of an issue with a Vendor's

{Bidder's} Small, Minority, Veteran, and Women Owned Business Certification status, *NJSTART* provides a link to take corrective action.

Inasmuch as this is a full or partial set-aside Blanket P.O., the Vendor {Bidder} should provide, as part of its response to this Bid Solicitation, proof of its current registration as a qualifying small business with the New Jersey Division of Revenue and Enterprise Services, Small Business Registration and M/WBE Certification Services Unit. Application and registration requirements are presented on the web at http://www.nj.gov/njbusiness/contracting/ or by contacting that agency as indicated below during business hours.

** IF THE VENDOR {BIDDER} IS AN INCUMBENT VENDOR {CONTRACTOR} AND/OR HAS PREVIOUSLY REGISTERED OR BEEN CERTIFIED UNDER THE FORMER SBE/MBE/WBE PROGRAM, THE VENDOR {BIDDER} SHOULD ENSURE IT IS REGISTERED ON THE DAY OF QUOTE RECEIPT WITH THE DIVISION OF REVENUE AND ENTERPRISE SERVICES, SMALL BUSINESS REGISTRATION AND M/WBE CERTIFICATION SERVICES UNIT TO BE ELIGIBLE FOR AWARD.

[Bid Solicitation Section § 4.4.1.4.1 Small Business Set-Aside Blanket P.O. Emphasis added.]

Further, the Bid Solicitation notified Vendors Bidders that they could verify their certification status in **NJSTART**. Specifically, Bid Solicitation Section 4.4.1.4 Small Business Registration For Set-Aside Blanket P.O.

Vendors {Bidders} should verify its Small, Minority, Veteran, and Women Owned Business Certification status on the "Maintain Terms and Categories" Tab within its profile in *NJSTART*. In the event of an issue with a Vendor's {Bidder's} Small, Minority, Veteran, and Women Owned

Business Certification status, *NJSTART* provides a link to take corrective action.

Moreover, in response to a question posed by a potential Vendor {Bidder}, in Bid Amendment #2, the Bureau confirmed the requirement that a Vendor {Bidder} must be registered as Small Business Enterprise by the Quote opening date.

A review of the records maintained by DORES reveals that Haines was not certified as Small Business Enterprise on April 11, 2019, the Quote opening date. The records reveal that Haines received its initial certification as a Small Business Enterprise on or about December 7, 2004; however, that certification expired on December 6, 2005. Haines renewed its certification on December 12, 2005 (expired on December 11 2006); May 16, 2007 (expired on May 15, 2008); April 22, 2010 (expired on April 21, 2013); May 6, 2013 (revoked on August 3, 2014); May 12, 2015 (revoked on August 10, 2017); January 8, 2018 (revoked on April 8, 2019); and, then September 3, 2019.

With respect to the subject Bid Solicitation, Haines was certified as Small Business Enterprise on January 8, 2018. As required by the applicable regulations, Haines was required to submit its Small Business Enterprise Annual Verification Form on January 8, 2019. Specifically, the regulations provide in part:


- (e) Annually the business shall submit, prior to the anniversary of the registration notice, a verification statement, in which it shall attest that there has been no change in the ownership, revenue eligibility, or control of the business at the State's website, https://www.niportal.com/DOR/SBERegistry/.
 - 1. If the business fails to submit the annual verification statement by the anniversary date of the registration notice, the registration will lapse and the business will be deemed revoked from the State's small business database. If the business seeks to be registered after revocation, it will have to reapply and pay the \$167.00 application fee.

In November 2018, DORES, the certifying entity, notified Haines that it was required to submit the Small Business Enterprise Annual Verification Form by January 8, 2019.




Haines did not submit its Small Business Enterprise Annual Verification Form; and therefore, its Small Business Enterprise certification was revoked.

On April 9, 2019, Haines uploaded the documents comprising its Quote in response to the subject Bid Solicitation.

At the time that Haines uploaded its Quote documents, its Small Business Enterprise certification was revoked. At the time that Haines uploaded its Quote documents, its *NJSTART* Vendor Profile indicated that its Small Business Enterprise certification was revoked.



As advised in Bid Solicitation Section 4.4.1.4 Small Business Registration For Set-Aside Blanket P.O. and Bid Solicitation Section § 4.4.1.4.1 Small Business Set-Aside Blanket P.O., had Haines reviewed the Terms and Categories Tab within its NJSTART Vendor Profile, it would have been aware that its Small Business Enterprise status was revoked. At that time, prior to the Quote opening of April 11, 2019, Haines could have taken steps to cure the revocation. Further, as noted above, Haines' Annual Verification Form was due on January 8, 2019. Had Haines become re-certified at any time between January 8, 2019, the Quote Advertising date, and April 11, 2019, the Quote opening date, (a period of more than three months), Haines may have been eligible for an award.

Subsequent to the issuance of the NOI, Haines states that it filed an application for re-certification as a Small Business Enterprise. However, when attempting to file the on-line application it encountered an error message and was compelled to file a paper application. Haines further alleges that it was told that the review of its application could be delayed due to the high volume of requests received. Haines' application for re-certification was ultimately received on August 28, 2019 and approved with an effective date of

September 3, 2019. Regardless of the length of time it took for Haines' application for re-certification to be approved, Haines' certification was too late for it to be eligible for a Blanket P.O. award for the subject Bid Solicitation as certification was required prior to Quote opening. See, N.J.S.A. 52:32-25 (stating "when a contract or portion thereof has been designated as a set-aside, invitations for bids shall be confined to businesses designated by the department as appropriate for the set-aside and bids from other bidders shall be rejected.") Unfortunately, the Division does not have the power to waive the legislative requirement that a Vendor {Bidder} be certified as a Small Business Enterprise as of the Quote opening date. Only the New Jersey Legislature can change a requirement it has mandated.

Finally, in its protest Haines alleges that there must have been systemic problem with the certification system as "nearly half of the 34 applicants" were disqualified. See, Haines' protest letter p. 2. A review of those Vendors {Bidders} who submitted Quotes in response to the Bid Solicitation reveals that of the 34 Quote received, eleven of the sixteen Vendors {Bidders} who are listed for award received the Small Business Enterprise certification between Quote advertising date (January 18, 2019) and the Quote opening date (April 11, 2019.) The remaining five Vendors {Bidders} who are listed for award were previously certified. Of those Vendors {Bidders} who are ineligible for a Blanket P.O. award, six have never applied for a Small Business Enterprise certification; seven were revoked/expired prior to the Quote opening date; two applied and received their Small Business Enterprise certifications after the NOI was issued; and, three were ineligible for other reasons.

Based on the findings set forth above. Haines is not eligible for a Blanket P.O. award as it was not certified as a Small Business Enterprise as of the Quote opening date. Accordingly, I must deny your request for eligibility to participate in the competition for the subject Blanket P.O. This is my final agency decision.
